

Seacoast Family YMCA Corporate Membership Agreement

The Seacoast Family YMCA agrees to provide a corporate membership as specified to the undersigned under the provision of the following:

1. The YMCA reserves the right to limit corporate memberships to 15% of total membership at any time.
2. The corporate membership rate will equal the current membership renewal rate minus 20%.
3. Corporate membership is offered twice per calendar year, on the anniversary of your corporate membership and again at 6 months. Employees who join at the 6 month window receive the 6 month corporate rate and need to reapply at the company's annual renewal date for an annual term. No 6 month memberships will be accepted at the annual renewal date.
4. In order to qualify for corporate membership, your company must:
 - a. Provide names, addresses, ages and membership level of all **(minimum of 5)** employees to be members through corporate membership;
 - b. Agree to no transferring of memberships;
 - c. Pay the joiner fee based on number of employees joining under corporate membership *the initial year* (see chart "A").

6. Corporate members retain full membership rights according to level of membership with unique cards
